## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to https://tumigenomics.com, and TUMI Genomics and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to TUMI Genomics include https://tumigenomics.com. The TUMI Genomics website is a ecommerce site. By using the TUMI Genomics website, you consent to the data practices described in this statement.

# Collection of your Personal Information

In order to better provide you with products and services offered, TUMI Genomics may collect personally identifiable information, such as your

- -First and Last Name
- -Mailing Address
- -E-mail Address
- -Phone Number

If you purchase TUMI Genomics's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) sending us an email message; (c) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

TUMI Genomics collects and uses your personal information to operate and deliver the services you have requested.

TUMI Genomics may also use your personally identifiable information to inform you of other products or services available from TUMI Genomics and its affiliates.

## **Sharing Information with Third Parties**

TUMI Genomics does not sell, rent or lease its customer lists to third parties.

TUMI Genomics may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to TUMI Genomics, and they are required to maintain the confidentiality of your information.

TUMI Genomics may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on TUMI Genomics or the site; (b) protect and defend the rights or property of TUMI Genomics; and/or (c) act under exigent circumstances to protect the personal safety of users of TUMI Genomics, or the public.

### Tracking User Behavior

## **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by TUMI Genomics. #### Use of Cookies

#### -SSL Protocol
